Case Log Guidelines:

1. The case logs reflect the candidate's mastery of general radiology and advanced imaging knowledge and skills. The skills represented in a case log should be from a case that represents mastery and knowledge of the skill and should NOT be from a case where the skill represented is performed for the first time. While it is highly recommended that candidates submit logs that vary in species, skills, and modalities, candidates are only required to have a minimum of two (2) species documented in their case logs.
2. Case logs are to be maintained for one (1) year immediately preceding the submission of the final application. For the 2023-2024 candidates, the case logs must be cases from 02/01/2023 - 01/31/2024. Cases used for a case log do not need to be the same case used for the corresponding skills on the skills list.
3. Candidates must submit a minimum of forty-five (45) case logs and not exceed sixty (60) case logs. Cases used for case logs do not need to be the same cases used for the represented skills on the skills list.
4. Candidates should only describe one skill per case log. A skill represented in a case log may not be duplicated in another case log. While not required, candidates are encouraged to submit case logs in represented skill list number order.
5. Candidates must use proper veterinary anatomic directional terms and their abbreviations when describing a skill. For correct veterinary anatomic directional terms and their abbreviations (accepted and approved by ACVR) and how to use them please reference: *Smallwood, J.E., Shively, M.J., Rendano, V.T and Habel, R.E. (1985), A Standardized Nomenclature for Radiographic Projections Used in Veterinary Medicine. Veterinary Radiology, 26: 2-9.*

The skill represented and described in each case log must have a comprehensive description of the skill and include the following:

- Date
- Advanced skill being represented
- Patient identification (name or hospital number)
- Patient signalment: species, breed, age, sex, and weight
- Brief case summary to include presenting complaint, relevant initial findings from physical exam, blood work, or any other additional examinations such as neurological or orthopedic exams, and why the imaging study was requested. The brief case summary should be condensed to 3-4 sentences.
- Detailed summary of the diagnostic imaging technique and procedure performed by the candidate for the patient's imaging exam, including type and length of study. Candidates should describe the skill that demonstrates mastery in execution as well as use of correct terminology. Descriptions should be very detailed and include information such as landmarks, collimation, positions, and exposure techniques.
- Brief summary explaining the relevant findings in the radiology report, the outcome of the case, and veterinary diagnosis. This should be condensed to 3-4 sentences. Candidates should be aware that the radiology report and final diagnosis are different. A radiology report helps provide findings that lead to a diagnosis but is not the diagnosis alone.

Case logs are to be completed between 02/01/2023 and 01/31/2024

Final Applications are due February 1, 2024 at 12:00 A.M (E.S.T)
